HEALTH & SAFETY PROTOCOLS

Due to COVID-19, we have made some adjustments to golf camp this summer in compliance with the guidelines from the CDC, State government and the American Camp Association. Please review complete information on their websites: NH.gov – Stay a Home 2.0 – Day Camps, cdc.gov – camps and the American Camp Association at acacamps.org.

In summary, Foster's Golf Camp will follow the recommended guidelines of promoting hygiene, executing increased cleaning/disinfecting, encouraging social distancing, maintaining small groups, minimizing mixing between groups and training of all staff/CITs. Please see below our safety protocols that will be in place this summer.

Drop-off/Pick-up:

Maintain 6' social distancing at all times. No congregating around the bus. Adults doing drop-off and pick-up are encouraged to wear a mask/face covering.

Boarding the Bus:

A daily health screening questionnaire and digital touchless thermometer fever check will be conducted each morning. Campers will be instructed to use the touchless hand sanitizer dispenser outside the bus before boarding. Campers will be assigned a seat number and encouraged to sit in that seat for the week. The seat numbers are staggered to create the best social distancing scenario. Campers will be asked to wear mask/face coverings will traveling.

Windows will be opened to improve ventilation. The bus will be cleaned and disinfected after each use. There will be no access to the bus once campers arrive at the golf course. All equipment/backpacks will be removed from bus and kept in a designated area.

Bus Capacity:

At this time, the state's guideline regarding transportation limits the number of campers on the bus to a 50% capacity. Some families have offered to provide their own transportation.

Once the bus is at capacity, the option to provide your own transportation will be available. This restriction may be changed at the next press conference mid-June.

At the Golf Courses:

Golf is inherently consistent with "social distancing" small groups and without any close physical interaction among players or staff. The 3 courses that we attend Brookstone, Hidden Valley and Bolduc Park are following the state's guidelines in place for golf courses to be able to operate during COVID-19. Those golf course guidelines can be found on NH.gov.

Snack & Lunch:

Campers will not gather in groups of more than 10 and mealtimes will be conducted in an outside designated area to encourage social distancing. We're asking that campers limit the sharing of food/drinks.

Field Trips:

The Wednesday and Friday field trips after golf are suspended for the time being. Hopefully, these restrictions will be relaxed before the end of summer. We're working on some other interesting and fun activity to replace the Weirs Beach and Fun Spot time slot. The trophy ceremony will be held at Bolduc Park on Fridays for now.

MISC:

Signage regarding proper hand washing and hygiene will be posted for campers and staff.

Club rentals are available but for this year we would prefer that campers have their own clubs. Clubs should be cleaned and disinfected after each use.

No sharing of equipment – golf clubs, tees, balls etc.
